# **2008 Association** Fees Are Due

### More Storm Damage to Steps & Walkways

Nor'easter storms have again damaged the ocean access steps, especially the northern steps. The Association has gotten a preliminary bid to fix the damage, and the repairs should be completed early in May. Until repairs are made, homeowners and guests should completely avoid using the northern steps and be cautious in using the middle and southern steps.



As a reminder, funding for all repairs that have to be made come from your \$75 annual membership fees, and we ask that all owners kindly pay their 2008 fee if it is still due.

# Reflective Address Signs on Ocean Access Steps

The brown signs are designed like the brown house number signs many homeowners have purchased from the Fire Department.

The Town of Duck is installing the three signs at no cost to the Association.

### **Automatic Notification For Association Website Updates**

Since the Association will be using the website to communicate information, you may want to receive automatic notification whenever there is a change posted to the website. Getting automatically posted when changes are made would eliminate the need to periodically scrolling through the website looking for new information.

All internet users can subscribe to RSS (Real Simple Syndication) to automatically receive notification of changes. There are several types of notification from which to select. An explanation of RSS and a description of the process to subscribe to RSS can be found on the Association website. RSS services are free.

To get started with RSS, click on the small orange icon below the blue 'Contact Us' link on the CDA website home page.

### **Trash & Recyclable Collections**

Trash collection days during the summer season (Memorial Day through Labor Day) in Carolina Dunes will continue to be Monday and Friday. It's particularly important for renters to use the Friday collection to avoid excessive amounts of trash over the weekend. It's a good idea to put trash collection information on your refrigerator door, especially for renters.

Recyclables should be placed in the blue containers and put out on Fridays. Do <u>not</u> put regular trash in the blue container!

# Keep Trash & Recyclable Containers Under Your House

Please make sure to put your containers out the night before and bring them back under your house after collection. The Town of Duck can fine owners who leave containers at the edge of the street. While we are not aware of any fines being levied, putting containers under the house does avoid the risk of a fine, eliminates possible obstacles to EMS vehicles and also improves the overall community appearance.
